There is also a report shown in the Verge Cutting Trial Final Report, with my comments shown on page 3 under 3.1 Reduced Visibility, demonstrating that I put forward the Bumpstead Ward's comments and concerns to BDC officers:-

Cllr Diana Garrod (District Councillor) - "Whilst I can see the benefits of this trial, I thought I should inform you that several people have mentioned reduced visibility whilst driving (and cycling) around some of our small and winding country roads where the plants, in particular Cow Parsley, has grown beyond one metre in height. Difficulties are compounded by the navigation of some deep potholes which some residents feel have a lower priority on the country lanes and are not repaired until they become very large. There have

also been several road diversions, which have therefore increased traffic on some lanes and several near misses conveyed to me in general discussions this weekend. I felt I should therefore convey this to you, so that this can be considered."

Stansted Airport draft Noise Action Plan 202428

This consultation ends on Monday 28th August 2023 and I understand that some parish councils in the Bumpstead Ward will not be meeting until September. Your Clerk may make a request for a dispensation to extend the time for a response at: community @stanstedairport.com

The NAP will be submitted to Defra in October 2023 with a view to adopting in February 2024 and publishing on their website. Consultation link: https://www.stanstedairport.com/community/

There is an undertaking to extend the period of fewer flights/reduced noise to 23.00-07.00 from 2026. The airport will be installing two additional noise monitors near the airport and there will be an on-line portal set up where noise and airport movements into and out of Stansted will be measured and recorded. This will be available to the public.

McDonald's Drive-Thru Restaurant

Plans for a McDonalds drive-thru restaurant at Haverhill Business Park in Helions Bumpstead have been approved. This includes 48 car parking spaces, including electric vehicle charging spaces, and a new play area. BDC says it will create more job opportunities in the local area and it's great to see a big name willing to invest in the village. BDC recognises some of the concerns raised regarding traffic generation and access and these issues were previously considered when the original outline planning application was granted for the business park. There was also concern about potential litter issues. While the applicant is proposing to put in place their own litter management strategy, as part of the decision on the planning application, the applicant will be encouraged to consider other measures which can be put in place to tackle this issue and assist with prosecution for littering in the local area. The Minutes of the planning meeting 4th July 2023 state: '*The Applicant and/or the Restaurant Manager should ensure regular litter patrols to cover the perimeter of the site in accordance with the submitted Corporate Litter Management Plan and to consider the use of customer/vehicle registration identification technique(s) and other measures to assist with prosecution for littering in the local and wider area'.*

Dedham Vale & Stour Valley Forum 2023 (Free to attend!)

This is an annual event where anyone with an interest and passion for conserving and enhancing the Dedham Vale National Landscape and Stour Valley can come together to discuss a range of issues affecting the area. It will take place on Thursday 14th September from 6:30pm (doors open at 6:00pm for light vegan refreshments) to 8:00pm with the option of a 'dark skies walk' afterwards. Our theme for this year is A National Landscape fit for the 21st century?
