Reports

Parish Council. Mr.G.Reeve Resumé given of matters covered over past year: Several permissive rides have been cleared; a proposal for public toilets was considered and abandoned due to exhorbitant cost involved. £100 was donated for the children's party held on the Green to celebrate the Royal Wedding on July 29th. £1506 was given for redecorating interior of Village Hall. Representatives of Council attended funeral of The Squire of Tatsfield Major Richard Leveson Gower and gave a donation in his memory to the League of Friends of Oxted Hospital. Complaints are continually received of rubbish in village and outside the hall & efforts will be made to provide more bins. Council increasingly concerned over erosion of Greens, Parish land & woodland and three matters are currently with solicitors. Mr. Reeve read the Minutes of the last Parish Council Meeting to illustrate the type of matters covered each month.

Playing Fields Association Mr. Buxton

Club registration certificate and licence for Bar obtained this year. Five showers installed and tiling will be carried out. Four senior teams use pitches and Colts use on certain occasions. All weather cricket mat purchased - but as yet there is no cricket club. Future plans: to provide tennis courts when money available. Sponsored smoking competition is being arranged and it is hoped to organise one activity each month to raise money to decorate throughout pavilion. A new Constitution has been drawn up.

Scout Group Mr.Geliot

There are 32 Cub Scouts and Nigel Shaw was commended for the amount of time and work he gives to the Cubs and also the Beavers which he started for 6-8 year olds. There are 14 Scouts and difficulty is experienced in retaining a high proportion of boys about 13 - 14 years old. Six week-end camps are arranged plus main summer camp in Lake District. Peter Vale and Peter Scarbore spend considerable time on running the Troop and the Group are indebted to the dedicated service of these three leaders. Thanks expressed to all who support the Scout Fete as this and the 100 Club are good fund raisers.

Group Chairman Mr. Biswas is rewiring and thanks expressed for his help to the Group.

Guide Company Mrs. Taylor

There are 14 Guides but difficult to retain interest after the age of $12\frac{1}{2}$. Camp held at Sheffield Park last year and girls are taken swimming once a week. The only fund raiser was a stall at the Scout Fete which raised £80. Mrs.Woolfrey now helps with the Guides.

Village Hall Mr. Hunt

Projects for past year included: internal re-decoration, stage and committee room flooring re-newed; new stage curtains and new electricity meters. Hall finances stretched and new scale of charges introduced from April 1st. New meters still being ill-used - charges for electricity were £671 and only £362 collected. Neters have now been removed and adjustments made to letting fees.

Tandridge District Council Mr.S.Dothie

South of the Downs Plan is in preparation and North of the Downs Plan will follow in next two years.

Surrey Structure Plan requires additional housing land in Tandridge District in next five years. 150 units required extra to those already in pipe line.

Concern expressed over size of some houses allowed on appeal by Inspector who tends to impose fower conditions on applications than if District Council had approved plana.

Warlingham school swimming pool now open to public following

- b. Mrs.Player said it was very difficult to negotiate stile opposite the Church. To be reported for attention to Land Agent for Park Farm.
- c. Complaints made to Mrs.Player over confusion of house numbers in Paynesfield Rd. which had the same numbers as houses of The Square fronting on to Paynesfield Rd. Residents to be advised to write to District Council.
- d. Refuse Collection. This was fully discussed with Mr.Simon Dothie, District Council Representative who said every Parish Council had written to the District Council also several hundred residents. It had been voted to change to privatisation for this service as being for the overall good of the District. Tandridge is the most expensive District in Surrey for refuse collection. The new service will operate from April 1983.
