Roads. The Chairman referred to the meeting
of Magistrates at Exeter on Dec 23rd 1912
in connection with the making of Payne's field,
Louisa & Emily roads, and said he was
glad ^{that} the objections raised had been
swept away. He spoke in eulogistic
terms of the manner in which the case
had been prepared by the District
Council and presented by the Officials,
every point had been considered and
was explained to the Magistrates. He
thought the thanks of the members of
the Parish Council was due to the
District Council and their Officials.

Mr Vincent proposed, seconded
by Mr Dent.
" That the thanks of this

Council are due to the Rural District Council of Godstone and the Officers of the Rural District Council of Godstone for the manner in which the case referring to the making up of the Painesfield, Louisa and Emily roads was prepared and presented before the Magistrates on Monday the 23rd December 1912."

"That the Rural District Council of Godstone be requested to apply to the Local Govt Board as early as possible for a loan for the making up of the Painesfield, Louisa & Emily roads, upon the best terms obtainable, but it is hoped that such loan may be made repayable by instalments to be spread over as many years as possible, with the option to the frontagers to pay the whole amount due from them, either at the completion ^{of the} work, or at any time after the completion of the work and before the final instalment will, in the ordinary ^{course,} ~~course~~ become due"

(Carried).

Police.

The chairman said he had seen Supr West with reference to the police supervision of the parish, and in respect ^{in respect} of damage to the lamps, the Supr said this would have his attention.

Breaches The Chairman called attention to a dangerous proceeding which had been taken by a Mr Geary in cutting a trench and erecting a fence over the Highway known as Park Wood Road, part of which had been in use by the public for some sixteen years.

Mr Vincent proposed seconded by Mr Dent:

"That the attention of the Godstone Rural District Council and the Police authorities be immediately drawn to a dangerous interference and destruction of the Highway known as Park Wood Rd, and that they be requested to at once take steps to rectify this matter, and that pending such rectification precaution be taken to fence and light the said Highway"

Ricketts
Ain. Mr Dent drew attention to a wire fence which had been put up at the Firs Ricketts Hill. He was not sure whether it did not constitute an encroachment, and suggested the Council calling the attention of Mr Crowter to the matter.

The Clerk was directed to write accordingly.

Matter. The Chairman said that his attention had been called to the question of the

10% guarantee charged by the Metropolitan Water Board for the Tatsfield water supply. He was not sure that the time was ripe to raise the question.

After discussion the matter was left in abeyance.

East Surrey.

Water Coy

The Chairman said that he would like to refer to the question of the Parliamentary Powers asked for by the East Surrey Water Co - though it was not on the agenda. Since the letter sent by the Council to the Local Govt Bd, he had received more information.

The sum for Preliminary Expenses recently voted by the Dist Council was in the interest of the whole district of Horsstone and would be spread over the whole district, just as when Tatsfield applied for their present water scheme, the preliminary expenses were spread over the whole district. As the Dist Council had supported Tatsfield, so he thought they might support the Dist Council. No charge for actual laying on of water in any of the parish would be borne by Tatsfield - it was restricted to a share of the Preliminary Expenses necessarily incurred in obtaining Parliamentary Powers. He would like to discuss the matter of the letter sent to the Local Govt Bd at their next meeting.

Minutes of a Parish Council Meeting held at the Schools on the above date.

Minutes of the previous Meeting were read, confirmed and signed.

Lavercombe's House. Mr Barroalete wrote that the question of the building material being used in the erection of a house by Mr Lavercombe would receive his attention.

Roads. The Rural District Council wrote that they had decided to make application to the Local Govt Bd. for a loan of £855 for the making up of Loursa, Emily, and Paynesfield roads, but the period of repayment they

thought would not extend beyond 7 years.

Photos of the Roads were also sent.

Obstruction The Rural District Council write Park Wood Rd. that they had not sufficient evidence before them to warrant any action being taken in regard to alleged obstruction at Park Wood Road.

Wire Fence. Mr Crowter write that the alleged encroachment at Ricketts Hill, ~~the~~ the erection of a wire fence would receive his attention.

Water Supply The Chairman read a letter from the Rural Dist. Council to the effect that as the water rates increase so the payment to the Met. Water Bd goes down. The highest amount on the precept has been for a half year £124-10-1. For the half year to 31st March 1913 as set £106-19-0 the lowest amount paid, so they were coming down in payment, but slowly.

The Clerk was instructed to write to the Dist Council asking if the guarantee payment would cease at the expiration of a certain number of years.

East Surrey Mr Brown said he was not aware when he protested ~~of~~

against the expenditure by the Dist Council
~~on~~ ^{on the occasion of the} the East Surrey Water Works asking for
 Parliamentary Powers for extension purposes,
 that the Dist Council had spent some
 £300 for the Tatsfield Water Supply.

Postal Service. The Surveyor G.P.C. Brydon wrote
 that no advantage would result to Tatsfield
 by the suggested alteration of Postal Service
 from Sevenoaks direction to Croydon

Finger Post. The Rural Dist Council wrote granting
 request for the erection of a Finger Post
 at Rickards Hill.

Lighting. Mr Vincent proposed, seconded by Mr
 Brown that Sipping be appointed
 Lamplighter (from Jan 27th) Mr Dasker
 having left the neighbourhood. Carried.

Red House Cottages. The Rural Dist Council wrote that
 the Sanitary Inspector had been instructed
 to report on Red House Cottages.

Lavercombe Property. Mr Brown said a Mr Gale had
 complained to him of the dampness of
 Daisy House which he Mr Gale rented
 off Mr Lavercombe.
 The Clerk was instructed to
 write to the Surveyor.

School Manager. The Surrey County Education Committee
 write asking as to the appointment
 of School Manager.

After discussion it was decided to leave the matter to the new Council.

Chairman. Mr Brown proposed, seconded by Mr Dent, that the appreciation of the Council for the services of the Chairman during his term of office be recorded in the minutes.

This was unanimously carried.

Croydon Extension The Chairman drew attention to a report in the Surrey Mirror of a proposed extension of the boundaries of Croydon Borough. He thought if it extended to Wokingham, it would be beneficial to try and get Tatsfield included, as no doubt the Croydon Borough would see that the included parishes were efficiently served.

Messrs J. Brown, A. Dent & J. Vincent expressed agreement with the Chairman.

The adjourned meeting of the ~~annual~~ Annual Parish Meeting was held at the Schools, on the above date, Mr S Joyce Thomas presiding. The attendance was small.

The Chairman reviewed the past year's work, and referred to the great assistance rendered by Mr J. Vincent. He also referred to the work done by Messrs J Brown, Grewest & Dent. He hoped the new Council would give attention to the questions of the making up of Louisa, Emily & Painesfield roads; footpaths; widening of the road near the School, and ~~the~~ housing.

Water Works
Mr A Hitchcock, ^{asked} why an addition completed some two years ago to the Limpfield & Osted Water Works, to which he had drawn the attention of the Overseers and Clerk, had not been assessed.

The Chairman read a letter from the boy stating that the additional building in course of erection would not be completed till May.

Mr Hitchcock said he did not

refers to the building now in course of erection which he knew could not be assessed till completed, but to an addition already completed previous to the present addition.

After discussion the Chairman asked the Overseers to work into the matter.

Croydon Pa.

Mr Duddy raised the question of Tatsfield paying for that portion of the Croydon road by the Rectory part of which was in the parish of Tisbury. It was understood from Mr Wilkins - District Councillor that the maintenance would be borne by the County Council.

Mr Brown pointed out that there was a general charge for the high roads of Godstone of which Tatsfield formed a part & irrespective of parishes. Tatsfield only paid their share of all the roads in all the parishes as did the other parishes.

The Chairman said that was so, and for the future the County Council would bear the cost of the upkeep of the portion of road referred to by Mr Duddy, & so relieve the general charge.
