Minutes of the proceedings of a Parish Council Meeting
held at The School^{Balfour}, Mon. July 7th, 1952.

Present Mr. Jones (Chairman) Miss Knight, Messrs. Drake, Ridler,
Simpson & the Clerk.

Apology
for Absence An apology for absence was received from Mr. Black & Mr. Hodson.

Minutes The Minutes of the last Meeting were read & confirmed.

Audit
(see P. 144) The Clerk said that there was nothing to report about
the Audit of 1951-52 ^{accs.} Regarding the 10/6 paid
by Mr. Ridler at April Meeting, the Clerk said she had
been under a misapprehension on the matter, and in
the circumstances had returned 10/6 to Mr. Ridler, as
the Auditor considered it unfair for one person to meet
the whole amount.

Main Drainage The Clerk read a letter from Godstone P.D.C. stating that
the proposed drainage scheme had been submitted to the
Drainage Committee, who in the first instance had instructed
the Engineer to approach officials of the Ministry of Housing
& Local Govt. as to the prospects of whether the whole
or what part of the scheme would be likely to receive
ministerial approval. Until some indication of the
attitude of the Ministry was available, it was useless
for them to meet representatives of the Parish Council.
There was every intention of letting the Parish Council know
what was intended in the matter.

Path opp.
Kew House A decision regarding this path is to be made at the
September meeting, as it was felt that not much
good would be done at the moment by putting down
a load of rubble.

Manor House
John's Rd
The difficulty regarding the lack of cross pieces to these stile was examined. Mr. Drake offered to see Mr. Coombs on the matter, & this was accepted.

Datsfield Green
It was reported that this Green had been cut by auto scythes & subsequently burned off.

School 'bus
Time
The matter of 8.15 School 'bus was discussed. Proposed by Mr. Simpson, see. Mrs. Knight that the Transport Authorities be asked to run this 'bus at 8.30 instead of, as at present, at 8.15, as this entailed the children arriving some time before the schools opened. In winter this created a hardship. As there was a Coach leaving the Village at 8.16 this alteration would not interfere with other passengers.
Carried.

Manor House
The Clerk reported that the seat at Datsfield Green had received attention. The matter of the seats once situated opp. Manor House, & ^{Church} School Hill corner 'bus stop was then discussed. These had become total losses during the war, probably through Army vehicles. Proposed Mr. Bidler, see. Mr. Simpson that the Highways Authorities be asked if these three seats could be replaced.
Carried.

Track near
Parkwood Rd.
The Clerk said that she had been asked by Mr. Watson, Parkwood Road, whether something could be done about putting the Track into better condition. He was prepared to contribute £1 towards the work. After discussion the Clerk was instructed to tell Mr. Watson that this matter did not come within the jurisdiction of the Parish Council & to suggest that he discuss the matter with other residents, & then see the owner of the Track.

'Buses
Chartwell

Mr. Simpson said that on the days that Chartwell was opened to the public there was very little hope of Tatsfield residents travelling either towards Westham or London by 'bus. He thought that the Transport Authorities should run special ^{relief} services on these days to thus avoid inconvenience to the other travellers. He was asked to prepare points for a letter to be sent by the Clerk.

Pits in Edward
VII memorial

Mrs. Smith of Heathview had reported that these wells or pits were uncovered, & she thought, a danger to children who sometimes went near them. Mr. Gray said that he would investigate, & if he thought there was a real danger, the Clerk was to be instructed to draw the attention of Godstone R.D.C. to the matter.

Minutes of the proceedings of a Parish Council Meeting held at The Bakery, on Monday, Sept. 1st, 1952

Present Miss Knight, Mr. Black, Mr. Drane & Mr. Simpson.

Chairman In the absence of the Chairman & Vice-Chairman proposed by Miss Knight, sec. Mr. Simpson that Mr. Drane be Chairman of the meeting. Carried.

School 'Bus

The Clerk read letters from London Transport stating that the Executive were unable to adopt the Council's suggestion for the 8:14 a.m. 'bus to leave 16 minutes later, as this would destroy the connection now made at Botley Hill with 'bus 464 proceeding to Oxted, & that children in the evening could take 'bus 464 to Botley Hill where they could then board a 403 6 minutes later, & walk only from Tubfield Rd. or Church Hill Corner.

Proposed Mr. Simpson sec. Mr. Black that the Education Authorities be asked to allow caretakers to open the Schools earlier & thus avoid the 30 minute wait as at present. Carried.

Seats on Green The Clerk said that she had been notified that the matter of replacing seats would be brought

OCTOBER 1952

The Chairman's Report

Minutes of the proceedings of a Parish Council Meeting held at The Bakery on Mon: Oct. 6th, 1952

Present. Mr. Geary (Chairman) Mrs Knight, Messrs. Diane, Hodgson, Ridler, Simpson & the Clerk

Apology An apology for absence was received from Mr. Black.

Minutes The minutes of the last meeting were read & confirmed

Main Drainage Mr. Easter, the Godstone R.D.C.'s Engineer & Surveyor, with his deputy, Mr. ~~Swain~~^{Swaine}, were invited by the Council to explain the proposed Drainage Scheme for Tatsfield, before the usual Council business began.

Mr. Easter said that there was hope of an early start, perhaps next Spring. It was proposed to connect with the West Kent sewers at the junction of Linstead Hall Lane & Ricketts Hill. To do the whole parish would be too expensive, therefore it had been divided into areas governed by density of population & levels. The densest area was around Westmore Green, & the second area adjoined Tatsfield Green as far as the School & along Old Lane. It was proposed to go ahead in these 2 areas to the extent to which the Ministry would go. The approximate cost for these two areas was £21,000, the number of houses roughly 150, 106 being in the first area, 36 + the school & possibly 9 others in the 2nd area. As regards the position of the individual householder there would be no compulsion to connect, except on the grounds of nuisance. The cost might be a possible average of £50, & there might be a scheme to enable householders to spread the cost of connection over a number of years.

Approximately 300 houses would complete the whole scheme. The first 2 areas could be done in about 9 months

The Chairman thanked Mr. Easton & Mr. ^{Swaine} Swaine for their kindness in coming to the meeting, & answering questions.

Path opp. Manor House The Clerk read a letter from Surrey C.C. Highways & Bridges Dept., saying that the matter raised would be investigated.

Schools at Warlingham The Clerk reported that the matter of opening the schools earlier was being enquired into by Ripate & Purley Div. Education Officers. The Clerk was instructed to inform the Ripate Div. Education Officer that the school referred to, ^{in his letter} as being in Chelsham, was really Warlingham Annex.

Alleged Encroachment Old Lane The Clerk reported that she had seen Mr. Charman on the matter, & he had shown her maps proving that he had, in fact, not taken in the full length of his ^{ground} ~~plot~~ by a matter of 18", & that previous to purchasing he had caused a search to be made. Mr. Charman being present at the meeting, the Council invited him to explain the position. It was decided that the Footpaths Comm. should visit the spot & report at next meeting.

Notments Rent The Clerk said that she had collected & paid into the Bank £2.16.0 being Notments Rent for $\frac{1}{2}$ year ending Sept. 29th, 1952.

Footpath No 28 The Clerk said that S.C.C. had written to inform the Parish Council that an objection had been received to the status of Right of Way No 28 as shown in Draft map & Statement. It was contended that No 28 is a C.R.F. After discussion, & looking at the map the Clerk was directed to inform S.C.C. that on all maps this path had been shown as B.R. & the Parish Council wished to claim No 28 as B.R. under the latest Act. 1949.

King George VI Memorial Fund Mrs. Ridler reported on the meeting he attended in Oxford of Chairmen & Vice Chairmen of Q.R.D. areas, to discuss the King George VI Memorial Fund. After discussion it was decided to ask the Women's Institute, Working Men's Club, Church Council & Sports Club to send a representative Committee to a meeting to be held at the Bakery, Mon. 13th Oct. at 8.0 p.m.

Cancellation of 'Bus 403 Chelsham - The School The Clerk read a letter from the 'Not So Young' Club Hon. Sec. asking the Parish Council to support their request to London Transport for the re-instatement of this 'bus on account of hardship to elderly people, or at least ¹⁵ on put it on once or twice a week, particularly on Friday afternoons. After discussion p. Mr. Drane sec. Miss Knight that the Hon. Sec. be written, that, whereas the Parish Council were sympathetic in principle, in view of past correspondence with Transport Authorities they did not think the request was likely to meet with any success, they would, therefore, not support the request. Carried.

Mr. Simpson wished his abstinence from voting for the resolution to be placed on record.

Dead Tree at Botley Hill. The Chairman said that he had been unable to find the dead tree mentioned by Mr. Abraham, who being present, was able to give more explicit information. The Chairman promised to look into the matter again.

Padlocks on Notice Boards The Clerk reported that the three padlocks on the Notice Boards were missing, some time between August 26th & Sept. 1st. She had reported the matter to the police. It was agreed that 3 others should be purchased

NOVEMBER 1952

Minutes of the proceedings of a Parish Council meeting held at The Bakery, on Mon: Nov. 3rd, 1952.

Present. Mr. Geary (Chairman) Miss Knight, Messrs. Drane, Hodgson, Ridley, Simpson & the Clerk.

Apology An apology for absence was received from Mr. Black.

Minutes The minutes of the last meeting were read & confirmed.

Main Drainage It was generally felt that an unfortunate impression had been made on G.R.D.C. at an apparent lack of interest on the part of Parish Council for Main Drainage. The Chairman & members of the Parish Council wholeheartedly supported the scheme.

Schools at Warlingham The Clerk read a letter from the Div. Education Officer for Warlingham in which the Headmaster was quoted as saying that "no girl is ever kept out of school at any time. If the weather is fine, the boys are not allowed inside until about 10 minutes before the beginning of morning session, but if the weather is wet or in any respect inclement, then they also are allowed in school as soon as they arrive. No complaint had been received from any parent on this subject."

Alleged encroachment Old Lane Miss Knight said that she had been to see the place. As far as she knew it seemed in order. She thought ^{is} an ^{is} misunderstanding may have arisen through the putting up of new wire.

George V₁ Memorial Fund The Chairman reported that a fairly good response had been received, & said he would take the envelopes down to Council Officers the next day.

- Dead Tree Bothy Hill The Clerk reported that Godstone had this water in hand
- Notice Boards The Chairman said he had been unable to procure the type of lock he wanted, but they were on order.
- "Fasshopper Inn" The Chairman reported having received a notice of an application to be made to the Licensing Justices in respect of these premises.
- Seat Tatsfield Green The Clerk reported that repairs were to be made to this seat soon.
- Path No 18 (Cudham Rd.) a contention had been received by Surrey C.C. that this was a "footpath only." The Clerk was instructed to inform S.C.C. that on the 100yr. old map this was marked as a road, & an old resident had declared that 50 years ago this Right of Way was the only one down to the houses at the foot of the hill. The Clerk was instructed to inform S.C.C. that the Parish Council wished this status to remain.
- Path Union Rd - Swedish Houses A complaint was received that vehicles were crossing the Common and using this path. It had not been claimed as a Right of Way, & had once been blocked with a stile & posts. p. Mr. Riddle, sec. Miss Knight that the names of those crossing the Common & using the path be obtained. Carried.
- Path No 26 Church Avenue A complaint was made that this path had been ploughed up. Proposed Mr. Riddle, sec. Mr. Simpson that Godstone R.D.C. be asked whether permission to plough had been obtained. Carried.
- Path village to Church A complaint was made that the contractor turning the field

at Ship Hill had taken his lorries across the footpath & made it very unpleasant to use.

It was agreed that the Clerk should write to Mr. Robinson asking him to request the contractor to restore the path at this point.

- Apology. An apology for absence was received from Mr. Dray.
- Minutes The Minutes of the last meeting were read & confirmed.
- George VI Memorial Fund The Chairman said that about £31 had been raised for the fund in the village, but he would obtain the exact figure.
Proposed Miss Knight sec. Mr. Ridler that the Rector be thanked for his services in this connection, also W.I. & Church Council. Carried.
- Path Union Rd + Swedish Home The Chairman said he had obtained the names of those alleged to be taking vehicles down his footpath, & would let the policeman have them soon.
- Path No 26 Church - Avenue The Clerk said that she had received a letter from Mr. W. County Div. 
