Mr. Jupp outlined the reason for the meeting being held, to discuss public views regarding the Interchange proposals and the Parish Council can act accordingly.

That speakers speak for no more than 3 minutes.

Council members spoke from the floor.

Mr. Jupp briefly outlined the routes of the link roads between the two other interchanges were to be made, at Snettisham and Sevenoaks, and that one link road would have an interchange on the liveliest of a few Tatsfield parishioners and a road works. An alternative proposal has been offered to the Parish Council to have a Road Construction Unit which was being considered. Mr. Jupp read out the Road Construction Unit's survey on the present time, without the interchange and with an interchange and how it would be in 20 years time. Mr. Jupp considered the interchange would benefit the village by providing easier access onto B 2024. Also that the B 2024 would be widened. The interchange was proposed on National issues, and would benefit Tatsfield residents.

The environment was a concern and Mr. Jupp thought that the two other interchanges would be quite adequate. Mr. Jupp reported on the schemes for the B 2024 improvement along Tatsfield Court Farm. The R.D.C. are satisfied that the B 2024 must be improved to motorway standard. Mrs. Dunn said that there must be an increase of traffic if the interchange was agreed upon, and she considered the interchange proposals must be resisted.

Mr. Jupp asked Mrs. Dunn to show the location of road planned for the interchange proposals made.

Mr. Jupp produced maps of relevant areas and confirmed that there was to be no interchange the B 2024, would be improved in parts and that some land had already been sold for that purpose.

Mr. Jupp considered that interchange was unnecessary as the B 2024 was not a main radial out of London and that the Snettisham and Sevenoaks interchanges connected with the main roads from London. This would mean that the road would be built to an A road quickly so that the Ministry bore some of the cost.
