Minutes of the Proceedings of a Parish Council Meeting, held
at the Bakery, Mon: May 5th, 1958

Present Dr. Sturton (Chairman), Mrs. Dohie, Miss Knight,
Messrs. Gray, Hodgson, Leslie, Smith & the Clerk

The Minutes of the last Meeting were read & confirmed.

The Clerk read a letter from R.D.C. Surveyor saying that in view of the letter from the Footpaths Society, and provided that the Parish Council could supply sufficient evidence of users, it might be worth while submitting a claim to the C.C. to be considered at the first revision. The Clerk said she had asked for a number of claim forms from the Footpaths Soc., & she would forward these as soon as they arrived, to Mrs. Dohie. Ten statements were considered sufficient for evidence of users.

The Clerk said that she had seen the Foreman, Mr. Datchelor, and explained about the road-block at the S. end of Ricketts Hill. She had telephoned the S.C.C. Surveyor that morning, to find out whether anything might be done to prevent this happening again, but was unable to speak to him.

The Clerk read a letter from the County Divisional Surveyor regarding Church Lane. The matter was being brought before the Committee, but there was no great prospect of works being undertaken in the immediate future.

Road The Surveyor said that this road would ultimately be considerably improved, and surveys were now taking place. No date for the start of these works could be given now.

on Green The Clerk said this matter had been attended to.

Stones at
"The Ship" The Clerk said that, while speaking to the police about the parking of cars on Westminster Green, she had referred to cars parked outside "The Ship". Her attention had ^{been} drawn to the boundary bricks set in the road. After some discussion, prop. Mr. Smith, sec. Mrs. Doherty that the Highways Authorities be asked what the position would be should the brewers, at some future date, decide to develop along this frontage.

Road. Lack of liaison between R.D.C. and private builders was again discussed, and it was agreed that this should be stricter.
- Audit The Clerk said that she had been informed that the Audit would take place on June 19th.
- School Barrier This matter is to be brought up at June Meeting.
- Allotments Applications from Mrs. Wilkinson to take over Mr. Rusken's Allotments as ^{the} latter did not appear to cultivate them, was not proceeded with, as Mr. Rusken had not signified his intention to give them up.

An application from Mrs. D. Foster was turned down, as it had been made too late.

It was agreed that allotments should be advertised on the Boards, before March 25th in 1959.

Miss Knight asked that R.D.C. be approached about the cutting of the Green, & the Clerk was instructed to do this

Library

A letter from Mrs. Hayman, Honorary Librarian, was read, in which she complained that a report of the A.P.M. in a local paper seemed to suggest dissatisfaction with the library service, and she wanted the matter clarified. Mrs. Hayman enclosed a letter from the County Deputy Librarian saying that considerable building development in certain parts of the County had caused a Committee to be set up to see whether the different areas were being adequately served. The Ministry of Education was considering library services throughout the United Kingdom, and changes in the exercise of library powers might be recommended, but that it was improbable that any changes would take place in the Rural library service.

The Clerk was instructed to write to Mrs. Hayman saying that no dissatisfaction with the helpers had been expressed. The services rendered by the volunteer librarians was greatly appreciated, & the remarks passed at the A.P.M. were along the lines of what had been said in the County Deputy Librarian's letter quoted above.

Old Lane A letter from R.D.C. was read saying that Old Lane had been inspected, & the Surveyor was satisfied with its condition. The contractors were responsible until the end of August 1958.

Apology for Absence: An apology for absence was received from Mrs. Leslie.

Election of Chairman: Proposed Mr. Hodgson, sec. Miss Knight, that Dr. Sturton be Chairman for ensuing year.

Vice-Chairman: Proposed Mrs. Dohie, sec. Mrs. Hodgson, that Miss Knight be Vice-Chairman for ensuing year. Carried

F/Ps Committee: Proposed Miss Knight, sec. Mr. Smith, that Mrs. Dohie & Mrs. Hodgson be elected to F/Ps Com: Carried.

Blocked roads

in Snow.

A letter from the County Divisional Surveyor was read, informing the Parish Council that an investigation of the particular case had been made. Conditions at the time were such that, had vehicles been diverted to erect noticeboards, considerable lengths of road might have become blocked while this was being done. Boards indicating "Road Closed" could only be erected at the request of the Police. The presence of such boards might put residents on the road returning to their homes in the position of making "considerable deviation unless they first drove up the alleged obstructed length to ascertain the exact point at which the block occurred. In view of these facts he did not feel that any case had been made out for his department to make a general practice of erecting "Road Closed" boards, & the sub-Committee accepted this view.

Church Lane

The County Divisional Surveyor informed the Parish Council that his Committee was unable to recommend any improvement at Church Lane at the present time.

Croydon - Westerham Road

The question of the improvement of the Westerham - Botley Hill Road B2024 is at present under consideration, & plans are being prepared. This information was contained in a letter from the Highway Dept.

The Ship
Forecourt

The County Divisional Surveyor said, in a letter, that over a period of years, it appeared that the boundary markers at The Ship had been buried, and an area beyond these limits repaired, possibly originally at the expense of the brewers, & subsequently tar sprayed during the general treatment of the adjoining road. In view of the considerable period during which the area had been open to the use of the public, he did not think the brewers would ever be likely to enclose the area.

R.D.C. wrote accepting responsibility for the maintenance of 2 seats the P.C. proposed to erect on Westmore Green. The Clerk was instructed to ask R.D.C. whether they could purchase seats more cheaply than the P.C.

The Pond

R.D.C. in a letter concurred with the proposal to carry out paving around the pond in square concrete slabs of random size, the Contractor had been asked to put the work in hand at an early date.

School Barrier

The Chairman said that he had been in communication with the Headmaster about ^{the} parking of cars in front of the School, & had been told that these could be parked inside the gates. The matter is to be raised at the next Managers Meeting.

- Huts in Goatfield Rd. Mrs. Leslie brought up the matter of huts in Goatfield Road, which, it was thought, the owners of the land in question were using as sleeping accommodation at intervals through the summer. It was thought that in February 1957 the use of these huts was restricted to keeping tools in. The Clerk was instructed to bring the matter to the notice of R.D.C.
- Choice of School for 11+ children Mrs. Dobbie brought up the matter of the lack of choice ^{in schools} now affecting Tatsfield children who succeeded in passing the 11+ examination. Whyteleafe Girls' School was unable to take any more children from Tatsfield. Those who went to Orsted Secondary School found it difficult to take part in after-school activities, owing to transport difficulties, & she considered these essential to the development of the children. The matter was discussed at length. Mr. Hodgson said he thought a taxi would be ruled out, owing to the expense.
