11.22.1824 To discuss sign surveys undertaken by Councillors and agree replacements needed

Sign survey to be discussed and ideas for sign replacement/purchase put forward.

Numerous issues with road signs through the village discussed. Neither speed sign appears to be working. Signs can be cleaned and straightened by the Parish Council. Most problems have already been reported to Highways.

Replacement village signs to be considered. Cllr Harris was previously informed by Cllr Guglielmi that the speed signs were not a priority for Essex Highways due to budget limitations.

Cllr Edwards to discuss the speed signs with Cllr Guglielmi to see if that is still the case, and if so, whether the Council can appoint someone local to investigate repairing them.

Cllr Edwards to raise the issue of the safety corner signage arrows at the end of Lodge Lane.

Cllr Harris suggests the Parish Council match fund the cost of new signage with Essex Highways to ensure our signage requests are prioritised.

Cllr Cauvain - drain cover in Crow Lane is 3' into the lane - dangerous to traffic. Cllr Edwards to contact Essex Highways.

Cllr Cronin suggests signs are cleaned as a first point of action. Decided to be actioned by the Parish Council in the spring.

Cllr Harris suggests signs with a message relating to slower and more careful driving are positioned through the village. Safety and usage of these signs discussed, and the idea discarded as the village has varied speed limits, conditions etc. It was felt these types of signs could cause more confusion for motorists.

Cllr Brattan suggests signage be purchased for wheelie bins throughout the village. Clerk to contact TDC to discuss.

11.22.1825 To discuss plans for a village celebration of the Coronation, announced as May 6th 2023 (with a Bank Holiday on May 8th)

Discussed at length - initial ideas of a quiz on the Friday evening and an activity and a cream tea on the Sunday. The Village Hall is already booked by the Parish Council for the Friday evening.

Clerk to investigate booking for the Sunday and obtain quotes for pottery painting for the Sunday. Further ideas/planning to be discussed at January's meeting. Clerk to add to Agenda.

11.22.1826 To discuss and decide on meeting dates for next year

11.22.1834 Clerk and Councillors reports/updates

Cllr Cronin - met with Clive Dawson from TDC to discuss the oak trees and the hedge in Chapel Lane. Cllr Cronin has asked him to investigate the status of the hedgerow as Cllr Cronin believes it should still be protected. Clive Dawson will not currently put TPO's on the oak trees along Chapel Lane, however he will note them. Cllr Harris will liaise with Cllr Cronin regarding this.

Cllr Edwards - noticeboard at Goose Green blew down in the recent high winds. Clerk to contact provider to ask about possible repairs.

Clerk - met with some FOTS representatives today and dogs on the park were mentioned - suggestion of a larger No Dogs sign supported by Council - Clerk to investigate costs for the next meeting

Clerk - new NALC Code of Conduct to be brought in once TDC have adopted it

Clerk - CGM have quoted for next year, 20% increase felt to be in keeping with current rises in inflation etc

Cllr Harris left the meeting.

11.22.1835 Proposal from Cllr Edwards to 'block off' green area outside of boundary fence for Goose Green car park and for the Parish Council to initiate and provide a prize for a safety poster competition at Tendring Primary School

Discussion regarding how best to stop parking on the grass outside of the fence which blocks the pavement for pedestrians. Stakes or posts proposed to be positioned along the edge of the grass with reflectors on them. Possibly sunk into concrete or hammered in. Rocks/cement lumps suggested on the edge of the grass.

Cllr Barker's husband and Cllr Cronin to set posts into the grass. Cllr Cauvain may have reflectors for the posts. Clerk to purchase extra reflectors if needed.

Proposal for this agreed by all.

Poster proposal and prize to be donated agreed by all. Clerk to contact the school in the new year.
