

Due to the Covid-19 pandemic lockdown measures we were unable to hold a physical meeting in the required time frame. The Clerk investigated remote options but at the time was unable to find a quorum number of our Councillors to agree to participate in a telephone or video meeting. Once restrictions allowed and we had received our paperwork back from our internal audit, that had to be held remotely, the Council were able to meet in person. Our Clerk phoned the office of PKF Littlejohn and explained our situation and was told it was not a problem. We started the inspection period as soon as was possible but it was one day later than the 1st September deadline.

Due to the length of the pandemic period the Council members agreed to hold telephone meetings and as such this issue should not happen again.
