WA36/21-22 TO ELECT A VICE CHAIRMAN

WA39/21-22 MINUTES OF THE MEETING HELD ON 24 JANUARY 2022.

WA40/21-22 PUBLIC PARTICIPATION

- i. A member of SWAP shared details on their recent activities to oppose the Prison proposal. A demonstration took place in Great Bardfield, presentations made the local history group, Wethersfield Airfield Museum gave a presentation in Sible Hedingham and SWAP gave a presentation there too. FOI's from BDC have been received which contain over 80 pages of communication between MOJ and BDC since 2016 on the prison proposal. Questions regarding this were put to BDC at their last council meeting as it is mentioned several times in the FOI's by BDC Counsellor(s) that the local Parish Councils are in favour of the proposed Prison site at Wethersfield which is not the case whatsoever. SWAP have also just launched their website and fundraising letters being finalised for distribution.
- ii. A member of the public shared details on their personal engagement with ECC and CPRE regarding the prison proposal and their opposition to it. It was further mentioned that Tendering had offered the MOJ sites for the Prisons however it was not considered or follow-up by the MOJ.
- iii. A member of the public asked where they could find more details about WASC and SWAP. Many people are not on social media or have access to computers. It was discussed that each WASC PC to update parishioner's WASC updates on their own websites and noticeboards.

Cllr Duffin entered the meeting at 7.36pm.

WA42/21-22 SUB-COMMITTEES UPDATE

Cllr A Hull gave an update on communications and strategy. A meeting with DIO 21st March, if okay with the committee it is proposed Cllr A Hull, Cllr J Pearce, Cllr R Duffin, Sarah Seacombe and Mick Nash would attend. We have been told our consultants will not be allowed on base to undergo heritage/ecology assessments, but we shall be emailing the DIO before the meeting requesting that copies of the two masterplans be sent to us, so we can push forward with meaningful discussion.

FOI - A large number of documents /correspondences has been released by BDC after request from a member of WASC. Judging by what we have been allowed to see it is quite easy to come to the possible conclusion that BDC are supportive of the proposals and seem to be almost collaborating in their effort to get a positive outcome. This problem is probably compounded by the fact our Three Fields Ward councillor Peter Tattersley has reported back to BDC and MOJ stating how local PCs are positive about the prison proposals (quote emails). We feel we should give Councillor Tattersley the opportunity to explain and then retract this misrepresentation. It is abundantly clear that PCs are far from positive about the proposals. So, we shall be writing to Councillor Tattersley and others at BDC (and the MOJ if necessary) stating our position.

Councillor Butland. It has been drawn to my attention after speaking to several PCs that at the beginning of this process, various district councillors visited individual PC meetings all giving the same 'advice'. That all PCs should concentrate on what they can get out of the prisons being built rather than focus their effort on trying to stop the prisons being built. Heavily implying that the process was a done deal and will get passed by the Secretary of State regardless of protest or objection from a parish or district council. This 'advice' coupled with the now infamous article in the Dunmow Broadcaster back in 2016 where Councillor Butland clearly stated his personal opinion that the prisons were a great idea for the site, well, this does not sit well with our subcommittee. This misinformation, given from a council leader, from the outset, could be seen, by some, to be a flagrant attempt to influence PC actions. Many of us here today were at the initial meeting in this very building where Councillor Butland, Councillor Tattersley, Councillor Santomauro, and Councillor Van Dulken all sat here saying the very same thing, get what we can out of it. We feel this attempt to influence us needs addressing, can others here please advise if their PCs had the same visits where the same 'advice' was given? If deemed serious enough, we believe this issue should be brought to the attention of the monitoring officer.

Future strategy, awaiting initial consultation work as explained by Cllr J Pearce.

Each individual PC try to raise awareness in their own parish and hopefully be prepared to help circulate leaflets produced by SWAP.

Cllr J Pearce gave an update on Technical Work Program (see below). Database is progress as is the Digital model. Drone footage has been taken of

Five Wells and the link will be sent to all members to understand further the huge scale of the development, although this is only half the size of the same proposed in Wethersfield. The Landscape character assessment contract has Awarded to CBA and under the initial budget. The assessment will include a baseline assessment plus five different viewpoints.
