The Toppesfield and Gainsford End Neighbourhood Plan Steering Group has drawn up a Neighbourhood Plan which will help steer the future of the village between now and 2038. It gives the community the chance to have an influence over planning policy and gives us an opportunity to plan our own future. The Neighbourhood Plan works alongside Braintree District Council's Local Plan.

In 2019 it was decided that the process for a Neighbourhood Plan for Toppesfield and Gainsford End should begin.
