County Broadband have been developing the installation of ultra-fast fibre optic to the Parish.	<b>Parish Champion</b> Howard Walkden	County Broadband began undertaking the installation of fibre optic broadband at the beginning of 2020	County Broadband indicated that Fibre Optic Broadband should be available by the end of 2020. The work is still ongoing in 2021-22.

<b>Traffic Calming Station Road and Bures Road/Jupes Hill.</b>	Continue to try to progress improvements to traffic calming and speed restrictions throughout the Parish to enhance the safety for pedestrians and drivers. Joint Village Parish meetings have been undertaken and proposals have been taken to the ECC Portfolio holder and LHP. ECC Portfolio holder visited with Cllr. A Brown to view and discuss to visit the traffic problems. Further proposals re Station Rd, Lane Rd and a Zebra Crossing on A1124 have been submitted to the LHP in February and March 2021. A public meeting was held (9.3.22) and incremental speed restrictions (40-30-20) were prioritised to request from ECC by Co. Cllr Barber.	Monica Taylor	Adjoining Parishes ECC Co. Cllr.
