The Clerk, today, has placed further advertisements in the notice boards for the vacancies on the Parish Council for Councillors. To date no person has applied for the positions

124/2024 Update on Station Road Action Group / traffic issues - Cllr W. Sunnucks

D. Stocker has been the most active member of the Action Group. Speed signs have been erected. A meeting with ECC Highways John Simmonds was arranged. A few ideas were mentioned. The lack of pavement along Station Road was mentioned. A SID was suggested and a one-way traffic system to be introduced. The committee proposal was to wind up the Action Group and the Chair stated a great thanks to Denise and Paul for all their hard work.

A Speed Indicator Device (SID) was costed at £5283.00p including data breakdown. A SID for Station Road is £4678.00p. It can go on existing pole. A two-way installation costs a £150 extra cost to have the camera operating in both direction at the same time.

125/2024 Call for sites – update from Cllr W. Sunnucks and Cllr P. Chillingworth

2 officers from CCC met at Wakes Colne. 1 large site is in the boundary which is at the rear of the village hall. A lot of sites put forward are not in the village envelope. CC C gave the impression that they require large sites to be developed. They will come back with their proposals in due course. More organic growth of houses but with sustainability. Chappel has a proposal of 30 dwellings which would impinge on Wakes Colne. CCC had a house number of 920 which has now been increased to 1290 in house building.

A public meeting was held a number of years ago regarding getting a neighbourhood plan for Wakes Colne.

No volunteers came forward to help with setting up the plan.
