Priorities for WCA in 2023/2024

Crime and antisocial behaviour

Drug-trafficking and abuse in WCA area

• There was discussion on drug-traficking in the York area relating to County Lines and its impact in the WCA locality.

Background

County Lines

- County Lines is where illegal drugs are transported from one area to another, often across police and local authority boundaries (although not exclusively), usually by children or vulnerable people who are coerced into it by gangs.
- The 'County Line' is the mobile phone line used to take the orders of drugs. Importing areas (areas where the drugs are taken to) are reporting increased levels of violence and weapons-related crimes as a result of this trend.

National Police Chiefs' Council (NPCC) definition of a County Line

• The 2018 Home Office Serious Crime Strategy states the NPCC definition of a County Line is a term used to describe gangs and organised criminal networks involved in exporting illegal drugs into one or more importing areas [within the UK], using dedicated mobile phone lines or other form of "deal line". They are likely to exploit children and vulnerable adults to move [and store] the drugs and money and they will often use coercion, intimidation, violence (including sexual violence) and weapons.

Exploitation of young and vulnerable people

- A common feature in county lines drug supply is the exploitation of young and vulnerable people. The dealers will frequently target children and adults - often with mental health or addiction problems - to act as drug runners or move cash so they can stay under the radar of law enforcement.
- In some cases the dealers will take over a local property, normally belonging to a vulnerable person, and use it to operate their criminal activity from. This is known as cuckooing.

- People exploited in this way will quite often be exposed to physical, mental and sexual abuse, and in some instances will be trafficked to areas a long way from home as part of the network's drug dealing business.
- As we have seen in child sexual exploitation, children often don't see themselves as victims or realise they have been groomed to get involved in criminality. So it's important that we all play our part to understand county lines and speak out if we have concerns.

How do you know if County Lines drug dealing is happening in your area?

Some signs to look out for include:

- An increase in visitors and cars to a house or flat
- New faces appearing at the house or flat
- New and regularly changing residents (e.g different accents compared to local accent
- Change in resident's mood and/or demeanour (e.g. secretive/ withdrawn/ aggressive/ emotional)
- Substance misuse and/or drug paraphernalia
- Changes in the way young people you might know dress
- Unexplained, sometimes unaffordable new things (e.g clothes, jewellery, cars etc)
- Residents or young people you know going missing, maybe for long periods of time
- Young people seen in different cars/taxis driven by unknown adults
- Young people seeming unfamiliar with your community or where they are
- Truancy, exclusion, disengagement from school
- An increase in anti-social behaviour in the community
- Unexplained injuries

Calder House

- Discussion of recent developments at a property in Calder House.
- A resident has been recently charged by the police and acquitted.
- Separately Paul Morrison and Matthew Ward CYC ASBO unit have engaged in discussion with a group of local residents, and are continuing to examine the case of the same resident.
- Councillors Merrett, Clarke and Melly to seek clarification on CYC ASBO intentions and actions in regard to the case.

Background

- The Anti-Social Behaviour Officer (ASBO) CYC currently managing the tenancy at Calder House is in contact with a number of local residents who regularly report problems due to shouting etc.
- Any reports of Anti-Social Behaviour (ASB) should be passed on to this officer as there is a need to know what is affecting people.
- The ASBO intends to serve a notice of seeking possession against ASB offenders, and needs to include as many reports as possible to capture a true picture of the nuisance being caused.

Robinson Court

Changing Lives

- There was discussion about the role and responsibilities of Changing Lives supervisors at Robinson Court.
- Robinson Court supervisor(s) has not to date taken up invitation to attend WCA open meeting.

- Changing Lives wish to work collaboratively in partnership with the committee and local residents so that we can respond and resolve any issues with ASB that directly involve clients from Robinson court.
- We have licence agreements that all clients sign up to on admission to the service which
 outlines specific conditions they need to adhere to during their stay. We work intensively
 with clients around any issues regarding ASB and have internal policy to address any
 issues.
- Our aim is to try where possible to avoid clients losing their accommodation as this can then lead to increased issues impacting on the local community.
