# Merry Christmas and Best Wishes for 2025

## **Chairperson Report**

At the time of writing the group have organised and completed, in this quarter, 12 walks with 1 more planned taking us to the end of the year.

The walk programme is a major part of the role of the footpath group but we also dedicate a lot of time reporting problems that we become aware of on definitive public rights of way. In the last year we have reported 29 paths and have had 12 satisfactory outcomes. We are currently involved with Lancashire County Council, Public Rights of Way, about a proposed diversion of Footpath FP0804018 in Aughton, Ormskirk. And with Halsall Parish Council over a longstanding issue with FP0809028. In both of these cases we are being supported by Open Spaces Society, whose knowledge and experience has been invaluable.

We held our AGM on Sunday 8 December 2024 at Old Hollow Farm, Banks. It was well attended despite the problems caused by storm Darragh and road closures in the area. The existing committee was unanimously re-elected to their roles.

After the meeting a volunteer came forward to join the committee, Neil Ellis. This will be formalised at the next committee meeting in February 2025.

## **Subscriptions:**

We are pleased to be able to report that the membership fee for the year 1 January 2025 – 31 December 2025 can remain at £5 individual or £10 family membership. This needs in the region of 90 paid members to meet our standing costs of insurance, web hosting fees, Ramblers affiliation and domain register charges; in addition to successful bidding to the Eric Wright Trust for a grant to meet the insurance bill. The healthy financial report issued at the AGM shows that the costs which are due in Jan, Feb and Sept 2025 can be met.

The success of bidding for and receiving the Eric Wright Grant is due to the work undertaken by our treasurer David and the Support of West Lancashire CVS.

### The walks programme

The Walks Coordinator's Report was sent out with the AGM documents to all current members.

This item appeared on our last Newsletter but is worth a reminder about encountering livestock. Most of us aren't concerned about sheep but are wary of cattle and horses. Below is some guidance from Ramblers.

- Have a look when you reach the edge of the field. Are there any cattle in the field, any cows with calves, horses, or sheep? Cows with calves are the most common cause of problems for walkers.
- Keep a good distance from the animals. If they are on the path, then you're allowed
  to go off path to walk around them. If you are on open access land, then you can
  walk across the field to give the animals space.
- Walk quickly and quietly. Animals in a field may approach you, especially groups of cows which can be quite intimidating. If you panic, or run from them, they may also start running.
- Do not approach any animals, do not feed them, or touch them. Animals on a farm will have strict diets, especially horses, and feeding them can be bad for them.
- Leave any gates as you find them. Close any gates that you open, and if any gates are open, then leave them that way.
