Chairperson Report

The group has had a good start to the New Year with six successful walks completed at the time of writing this newsletter. There are three walks still available in this quarter. The next programme will be sent out with this Newsletter. It will also be posted on our Facebook page. Chris posts an event on Facebook about a week before the next walk is due with a picture and detailed up to date information on the route provided by the walk leader.

As part of our effort as a committee to meet our Charity Status our account of income and expenditure for the period 1 Oct 2023 – 30 Sept 2024 has now been submitted and can be seen on the Charity Commission website.

We have also posted our Constitution document (created 27 Oct 2001) onto our website following guidance from the Commission.

For a number of years the West Lancashire Footpath Group has paid an affiliation fee to Ramblers. As a benefit of this we have now been added to The Walking Partnership.

Treasurer Report

Explanation of our Funds

At our most recent AGM a question arose over the use of our available funds. The WLFG operate under charitable status and therefore need to cover all of our outgoings predominantly through our (small) Membership Fee.

We do have a few 'fixed' costs for which, it is felt, clarification is needed:

All of our walks for Members and Visitors are covered by a comprehensive insurance policy in the event of an unfortunate occurrence during the walk. Currently, through our

paid affiliation to the Ramblers' Association, by using their nationally agreed Insurance Policy WLFG receive a preferential premium. Having compared this figure with costings received form independent insurance providers it is clear that it is to our advantage to remain within the arrangements through the Ramblers' Association Policy. In practical terms this means that the Group pay a membership fee to the Ramblers' Association that enables WLFG to enjoy a comprehensive insurance policy for a combined cost less than that which could be achieved by entering into a direct independent agreement with an insurance provider.

Additionally, we are required to pay fees for the hosting of our website and domain register. In today's modern world electronic communication provided the Group with the most effective means to communicate with Members and provide you with the very latest information on our Walk Programme. It also reduces the high costs associated with any correspondence that may, in the past, have been sent out through the Royal Mail.

Your Treasurer continues to monitor the availability of grants, or other additional income streams, and will submit applications as, and when, appropriate to reduce any financial burden on the membership

We are continually looking at ways to minimise our Group expenditure, to ensure our Membership fees remains extremely competitive, providing value for money, whilst taking into account the number of walks organised on your behalf throughout the year.

Footpath Report.

There are two ongoing cases that we are involved with:

 Halsall footpath 28. With support from Open Spaces Society and Halsall Parish Council we are hoping to resolve the longstanding issue of this footpath terminating in a dead end.

If any members could provide evidence of getting through to Plex Lane and the route they used please let someone on the committee know. This will help in our discussions with Public Rights Of Way.

 Aughton Mickering Lane FP18. A definitive map modification request has been submitted by the landowner to move this path. The committee of the footpath group and Open Spaces Society have registered objections on the grounds of loss of amenity and health and safety of the proposed new route.

If any members or residents of Aughton could provide support for the objection, please let someone on the committee know. This path is part of a regular walk undertaken by the footpath and other groups but is regularly diverted because of unclear signage and obstacles on the route.
