WOTTON PARISH COUNCIL

Minutes of the Meeting of Wotton Parish Council held at 7pm on Tuesday 10 January 2023

Present: Councillors Peter Evelyn (Chairman), Jo Mansfield-Tubb (Vice Chairman), Andy Cole and the Clerk

(Note: It was impossible to hold the meeting in the Village Hall as there were no lights owing to a power cut. The meeting was therefore held in a side room at the Wotton Hatch pub.)

- **1. Apologies for absence:** Cllrs Laurence Matthews, Gary Burgess, David Mir, Steve Hackett. MVDC/SCC Cllr Hazel Watson.
- 2. Declarations of interest: None.
- 3. Public questions: None.
- **4. Minutes of the previous meeting:** Minutes of the previous meeting held on 4 October 2022 were proposed by Cllr Mansfield-Tubb, seconded by Cllr Andy Cole, agreed by all and signed by the Chairman.
- **5. Matters arising:** None.
- **6. Police report:** Councillors reviewed the report and discussed the call for any witnesses to a fatal accident at Ranmore Common Road on 4 November (see report attached).
- 7. Council elections: Elections will be held on 4 May for Mole Valley District Council and all 13 Parish Councils. There have been some boundary changes within Mole Valley since the previous elections. Wotton PC has 8 seats available and there is one vacancy currently. A prospective candidates evening will be held at Pippbrook in late February/early March. The clerk will attend this and collect information for Wotton councillors. It was agreed that a poster about the elections would be placed on noticeboards and the website. It was noted that there may be more than one vacancy by March. Cllr Cole agreed to place the election poster on Ranmore's noticeboard and the local WhatsApp group. Cllr Mansfield-Tubb suggested placing the information in the Vantage magazine which is distributed to every home.
- 8. Planning: The planning applications received and decided since the previous meeting were discussed (see attached). It was agreed that the improvements proposed in the National Trust's application relating to Leith Hill Place (MO/2022/1656/LBC) were beneficial and the clerk was asked to write a letter of support to Mole Valley.
- **9. Highways:** There was a discussion about the hazardous condition of certain roads currently owing to very heavy rain and spilled mud. Some drains had become blocked which was causing large pools of water to sit on the road surface. In some places motorists were pulling into the middle of the road to avoid the lakes of water.

10. Clerk's report:

- (i) An old bible containing information about local people had been received from the family of a previous resident. This was inspected and it was decided that the bible should be given to the Parochial Church Clerk, Mrs Wakeford.
- (ii) A letter to the NatWest requesting closure of the Parish Council's accounts and transfer of all funds to the UnityTrust Bank account was signed by Cllr Mansfield-Tubb, who agreed to deliver it to Cllr Matthews for his signature before posting it to the Dorking branch of the NatWest.
- (iii) An email to the National Trust asking to use their noticeboards for PC meeting agendas had been acknowledged by them, but the question was not answered yes or no.
- (iv) The clerk asked councillors about possible speakers to be invited to attend the Annual Residents Meeting on 7 March. There were a number of suggestions and enquiries will be made (MSS, Kingfisher Farm Shop/watercress, Albury Wine, Denbies Wine).

11. Finance:

- (i) A statement showing estimated expenditure, income, and bank balances at the end of the current financial year on 31 March 2023 had been prepared for councillors to review, together with a draft budget and precept recommendation for the year to 31 March 2024. It was recommended that the precept request remains the same as last year, i.e £7,264. This was proposed by Cllr Evelyn, seconded by Cllr Cole and agreed by all. The Precept request form was signed by Cllr Evelyn and Cllr Mansfield-Tubb.
- (ii) The statement showing bank balances, receipts, and payments had been circulated to all councillors. This was proposed by Cllr Evelyn, seconded by Cllr Cole and agreed by all present. The statement and cheques were signed by Cllr Evelyn and Cllr Mansfield-Tubb (see attached).

12. Correspondence:

- (i) MVDC had emailed asking if any CIL money had been spent by Wotton PC to date. Councillors did not remember receiving CIL money. *
- (ii) MVDC had emailed about the Platinum Jubilee Fund which opened on 20 December 2022. The Fund has been set up to provide grants to improve village hall facilities. This had been forwarded Mrs Wakeford for the Village Hall Committee. The application window closes on 20 January 2023.
- (iii) Surrey ALC had forwarded an email from SCC regarding the Future Bus Network consultation which closed the first week of January.
- (iv) Smaller Authorities Audit Appointments Ltd had written with notification of the external auditor appointment for 2022-23 financial year for a 5-year period until 2026-27. Wotton's appointed auditor will be PKF Littlejohn LLP.

- 14. Any other business for note or inclusion on a future agenda: None.

* Clerk replied to MVDC that no CIL money had been received. MVDC said £561.34 was paid to Wotton PC in August 2019. Bank statement confirms this. Minutes of October 2019 meeting do not refer to it. Clerk suggested to MVDC that the CIL money should be recorded as going towards the provision of one of the grit bins in Abinger Common Road to improve road safety.
