WOTTON PARISH COUNCIL

Minutes of the Annual Meeting of Wotton Parish Council held at 7pm on Tuesday 6 May 2025 in Wotton Village Hall

Appointment of Chairman: Cllr Burgess nominated Cllr Evelyn for the position of Chairman. All present agreed and Cllr Evelyn was duly elected in his absence. The Acceptance of Office form to be signed at the next meeting.

- 2 **Appointment of Vice Chairman:** Cllr Bennett nominated Cllr Cole for the position of Vice Chairman. All present agreed and Cllr Cole was duly elected.
- 3 Declarations of Interest: None.
- 4 **Public Questions:** A resident asked if anyone knew what was happening about the waterfall on Wotton Estate where a tree had fallen down and caused the waterfall to dry up. There was a short discussion and Cllr Matthews said that although it is not a matter for the Parish Council, he thought a grant had been applied for to enable the remedial works.
- Minutes of previous meetings: The minutes of the Parish Council Meeting on 7 January 2025, and the Annual Parish Residents Meeting on 4 March 2025, were proposed for acceptance by Cllr Cole, agreed by all, and signed.
- Police Report: (Annex 1) Regarding the report about a dead bird, Cllr Matthews said they have been contacted about a trap and a bird was released. There was a report about Pest Control advising there would be shooting 'at a location' on the estate. Cllr Cole asked if anyone knew how many foxes are being shot and what percentage are being allowed to run free. The problem of urban foxes being released in rural areas was discussed. Cllr Matthews said this is done by animal charities, but it does not work because foxes are territorial and when removed from their normal environment they find it difficult to survive. Cllr Bennett said there had been an accident at the top of Hollow Lane involving four cars recently and asked why it was not on the report. The clerk said she would try to find more details about it.
- 7 **Planning:** (Annex 2) Applications and decisions received since the Parish Council Meeting on 7 January 2025 were reviewed and there were no comments.
- 8 **Highways:** A width restriction sign approximately 5-10 metres from Sheephouse Green had been displaced. The clerk was asked to write to SCC to get it reinstated.
- 9 **Accounts for the year to 31 March 2025:** The accounts were approved and signed by Cllr Cole. The accounts will be published on the website.

- 10 **Risk Assessment, Financial Regulations, Standing Orders:** The documents had been reviewed by the clerk and sent to Councillors. These were approved by all present.
- Dates for Public Inspection of documents: The clerk confirmed this year's dates for statutory exercise of public rights of inspection of documents will start on Tuesday 3 June and end on Monday 14 July 2025. A notice will be placed on noticeboards and the website.
- 12 **Report from Auditor:** The report from Mulberrys following the internal audit on 1 May 2025 had been sent to Councillors. This was noted and accepted by all present.
- Annual Accounting Statements (AGAR): The Annual Accounting Statements were reviewed by Councillors and approved by all present.
- 14 Chairman to sign AGAR: Cllr Cole signed the Exemption Certificate on page 3 of the AGAR, for submission to the external auditors PKF Littlejohn, together with page 5, the Annual Governance Statement, and page 6, the Accounting Statements. The Annual Internal Audit Report, page 4 of the AGAR, had been signed by the auditor on 1 May. These documents will be published on the website.
- Finance: (i) The bank balance was noted and the bank statements were signed by Cllr Cole and Cllr Burgess. (ii) (Annex 3) Payments were agreed by all. The summary page was signed by Cllr Cole and Cllr Bennett.
- 16 **Reports:** None.
- 17 **Correspondence:** (Annex 4) All items noted. Councillors confirmed their support for Deborah Jones and Stuart McLachlan to continue as parish representatives on MVDC's Standards Committee.
- 18 **Dates of meetings:** (Annex 5) Noted.
- 19 Any other business for note or inclusion on a future agenda:
 - (i) Cllr Hackett said residents have an issue with the speed limit on Hollow Lane being 40 mph and are trying to get a petition together to request a reduction to 20 or 30 mph. It was noted that SCC Cllr Watson could be asked for advice about this at the next meeting on 11 October.
 - (ii) A question had been raised regarding the whereabouts of the silhouette at the top of Coast Hill. Cllr Matthews said it had fallen over and he had it in storage for the following year. He had not been present at the meeting where it was agreed to keep the silhouettes in place permanently. Cllr Matthews said he would replace it and make sure it was more secure so that it did not fall over again.
